Special order, custom built and non-stock items are non-cancelable and non-returnable. Normally stock items may be returned in original condition within 30 days from the date of delivery for credit or refund upon receiving a Return Merchandise Authorization (RMA) from the Seller. All returns not due to order filling error of the Seller shall be subject to a restocking charge of 15% of the purchase price.
